# Lutheran Church of the Redeemer Diversity/Equity Scholarship to Little Hands Big Hearts (LHBH) Christian Preschool Information

Lutheran Church of the Redeemer (LCR) in Woburn that has money available to provide tuition assistance for a family interested in sending a three- or four-year-old child to the Little Hands Big Hearts (LHBH) Preschool. The focus of this scholarship is to help ensure the diversity at LHBH reflects the diversity of our Woburn community and to foster inclusion. The family must live in Woburn and be able to provide transportation to and from the preschool. The child selected for the scholarship will have a place reserved for January 2022. Applications must be completed and received by LCR no later than September 30 2021.

#### **LHBH Preschool**

LHBH is a Christian Preschool that offers structure and creativity through play and teacher-guided activities. LHBH Preschool's goal is to have each child feel a sense of accomplishment in self-help tasks and to be comfortable in group situations, while looking forward to the kindergarten experience ahead. LHBH is located minutes from Rt. 128 and I-93 in Woburn and housed in the Education Wing of the Lutheran Church of the Redeemer, 60 Forest Park Road, Woburn, MA 01801. ## **Criteria for Awarding the Scholarship**

- Preference to recipients who would help the LHBH ethnic/racial diversity to get closer to the diversity in the Woburn Public Schools and where the scholarship would allow family members to improve the economic circumstances of the family
- Family lives in the town of Woburn and can provide transportation to and from LHBH
- Recommendation letter

## Scholarship Available for Child to Start January 2022

- The scholarship recipient will receive both tuition assistance and be admitted into the LHBH Preschool starting in its January 2022 term
- Starting January 2022, there is funding and a place set aside at LHBH for one 3 or 4 year old for Session 3 (7am to 3pm Monday through Friday)
- LCR can currently commit to funding this scholarship through December 2022 for the recipient. LCR intends to raise additional funds for the scholarship and the priority is to continue to fund the scholarship recipient through to kindergarten before funding additional recipients
- LHBH Session 3 tuition for 3 or 4 years olds is currently \$12,180 per year. The scholarship will support 2/3 of that amount, with the family responsible for the remaining tuition (\$4,056 through December 2022)

#### **Application Process**

- By September 30, 2021: Complete application by paper copy (PDF can be printed out and filled in) or Word application filled in electronically, along with letter of recommendation

It is expected that my/our child's attendance will be at least 90%. If attendance does not meet 90% and my/our child's absences are unexcused (examples of excused absences include child illness, family crisis), then the preschool director will speak with me/us about it. Ongoing attendance problems may result in the loss of the LCR Diversity/Inclusion Scholarship assistance.
- I understand that I/we will need to provide transportation for my child to and from LHBH preschool.
